Professional Profile

Dr. Daniel I Newman, M.D., N.D., M.S.O.M. is a *cum laude* (with honors) graduate of the State University of New York Downstate Medical College, where he was elected to the Alpha Omega Alpha National Honor Medical Society in 1981. He then completed a residency in Internal Medicine at U.C.L.A. affiliated hospitals, and has been **board certified by the American Board of Internal Medicine** since 1984. After a period of private practice, he completed a Pain Fellowship at the Sierra Pain Institute in Reno, Nevada, and has been **board certified by the American Board of Pain Medicine** since 1997.

Dr. Newman is a 1998 graduate of the U.C.L.A. Physician Acupuncture Program, and earned a **Master of Science in Oriental Medicine** at the National College of Naturopathic Medicine in June 2008. He completed a **Doctorate of Naturopathic Medicine** at the National College of Naturopathic Medicine in 2002, and is board certified by the North American Board of Naturopathic Examiners.

Dr. Newman logged over **10,000 hours of emergency medicine experience**. He has held certifications in Advanced Cardiac Life Support, Pediatric Advanced Life Support, and Advanced Trauma Life Support. He previously served as both an Advanced Cardiac Life Support Instructor and a member of the El Dorado-Sacramento Medical Society Emergency Care Committee.

Dr. Newman has served as the Pain Committee Co-Chair for Madigan Army Medical Center, where he received three Department of Defense **Special Recognition Awards** for the development of pain treatment protocols. He has **lectured internationally** on pain management as a faculty member of The Foundation for Medical Excellence.

Dr. Newman is currently licensed to practice in Oregon and Washington, and has previously held licensures in California, Nevada, and Hawaii. He has held **academic**

appointments in the Departments of Medicine at: **U.C.L.A., University of California at Davis, and University of Nevada, Reno.**

Dr. Newman is currently the **Clinic Director of Rising Health Wellness Center** in Vancouver, WA. Rising Health is an integrative medicine clinic offering holistic medical services, including: acupuncture, Chinese herbs, comprehensive diagnostic medical evaluation, detoxification, dietary counseling, homeopathy, intravenous (I.V.) services, internal medicine, joint and soft tissue manipulation, lifestyle counseling, nutritional supplementation, pain management, wellness optimization, Western herbs, and women's health services.
